The bid awards shall be made to the lowest responsible bidder taking into consideration the quality of the services to be provided, their conformity with specifications, the purposes for which required and the terms of service, local vendor preferences and other factors allowed for by the state bid law section 16-13 of the Alabama Code 1975.

The bid contract will be from May 13, 2022 through September 30, 2023. The BOE will have the option to extend the contract 4 additional years at the same contract price. The BOE has the right to reject any and all bids.
